GENERAL EVENT REGULATIONS

§1. Organizer and Purpose of the Event

- 1. The organizer of the event is the University Sports Association (AZS) Club of the Jagiellonian University Collegium Medicum, with the participation of the Department of Physical Education and Sports (SWFiS UJ CM).
- 2. The purpose of the event is to promote active recreation and a healthy lifestyle among the Jagiellonian University Collegium Medicum community.

§2. Date and Duration

- 1. The event takes place on the date specified and announced by the organizer in the official communication.
- 2. Participants acknowledge that registration for the event via email, participation, and entry to the premises constitute acceptance of these Regulations.

§3. Event Program

- 1. The program is published separately for each event by the organizer.
- 2. The organizer reserves the right to modify the program and will promptly notify participants of any changes via the event's website.

§4. Registration and Participation Rules

- 1. A participant is any person who:
- a) has an affiliation with the Jagiellonian University Collegium Medicum (as specified by the organizer),
 - b) has completed registration via email.
 - 2. Registration must be completed by the deadline or until all available spots are filled. The organizer may extend the registration period.
 - 3. Registration requires the participant's full name and other necessary information sent by email to the organizer.
 - 4. The organizer may record photos or videos of the event for documentation, information, and promotion.
 - 5. By participating, the participant consents to the use of their image for the purposes stated above without remuneration.

§5. Safety Regulations

1. Participants must comply with all safety, health, and fire regulations in force at the venue and follow staff instructions.

- 2. The organizer is not responsible for lost or stolen items.
- 3. The organizer has the right to inspect bags and use metal detectors for safety reasons. Refusal equals withdrawal from the event.
- 4. It is prohibited to bring weapons, explosives, flammable substances, or animals (except guide dogs).
- 5. It is forbidden to display political or ideological content or conduct unauthorized promotional activities.
- 6. Intoxicated or disruptive persons will be denied entry or removed from the event.
- 7. Event staff may verify identity, inspect belongings, issue warnings, or order removal from the venue.
- 8. The organizer is not liable for incidents caused by violation of these rules.
- 9. Participants are responsible for any damage caused to persons or property.
- 10. CCTV monitoring may be used for safety purposes.
- 11. Hazards must be reported immediately to staff.
- 12. Participants take part at their own risk. The organizer is not liable for accidents.

§6. Event Procedure

- 1. The event will be organized according to the rules set by the organizer.
- 2. Protests regarding results must be submitted in writing within 15 minutes after the event ends. The organizer's decision is final.
- 3. The organizer may change the date, venue, or program depending on the number of participants.

§7. Personal Data Protection

- 1. The data controller is Jagiellonian University, ul. Gołębia 24, 31-007 Kraków, represented by the Rector.

- 3. Personal data will be processed for event participation.
- 4. Providing personal data is voluntary but necessary for participation.
- 5. Data may be shared with referees and include images for documentation and promotion.
- 6. Data will not be transferred outside the European Economic Area.
- 7. Data recipients include IT service providers supporting the event.
- 8. Data will be stored until the event ends, and image data until consent is withdrawn.
- 9. Participants have the right to access, correct, delete, restrict, or transfer data, and to withdraw consent at any time.
- 10. Data will not be subject to automated decision-making or profiling.
- 11. Complaints may be submitted to the President of the Personal Data Protection Office (UODO).

§8. Amendments to the Regulations

- 1. These Regulations are available on the AZS UJ CM website. Registration implies acceptance of the Regulations and Image Use Consent.
- 2. The organizer may amend the Regulations due to legal, program, or safety changes.
- 3. Amendments take effect upon publication on the event website.

§9. Final Provisions

- 1. The Jagiellonian University reserves the right to cancel or modify the event without compensation, except refund of entry fees.
- 2. In matters not covered by these Regulations, applicable Polish law shall apply.
